DIVISION 44 EXECUTIVE COMMITTEE REPORTS

The following article was composed from the various reports of the committee chairs of Division 44's Executive Committee. These reports were submitted at the EC's annual Mid-Winter meeting, March 3-4.

Membership

(Christine Browning, Ph.D., Chair)

Currently Division 44 has 906 members. The division continues to maintain one of the best records of gender parity amongst APA's divisions. Women constitute 47.2% of the membership (428 members). Men constitute 49.2% (446 members). [The gender of thirty-two members (3.5%) is unknown.]

SPSLGI continues to grow at a steady pace. At its inception in August, 1986 the division had 709 members. SPSLGI has grown at a pace of approximately 50 members a year since its creation.

Since October, 1989 the division has received 325 requests for membership. This represents a dramatic increase in requests and could promise a surge in new members by APA's Convention in August.

Racial/Ethnic Minority Concerns (Connie Chan, Ph.D., Chair)

The committee wishes to commend Division 44 on its continued commitment to maintaining adequate inclusion of people of color on its governing boards. The committee recommends that SPSLGI's Policy and Procedures Manual be amended to include a statment advocating that a minimum of 25% of the division's elected officers be people of color. The Nominations and Elections committee would be charged with seeking nominations to reach the goal of this minimum. The committee would take responsibility to see that adequate representation of people of color would be maintained on Divison 44's standing committees.

The Forging Alliances IV Conversation Hour co-sponsored by Division 45 at Convention in

August will focus upon strengthening the community of lesbian and gay ethnic minority psychologists and supporters. Part of this hour will focus upon recruitment of members for specific tasks such as the possibility of co-sponsoring a conference (or leadership conference) between Divisions 44 and 45. This proposed conference would focus on gay-affirmative and culturally-affirmative approaches to psychology amongst other issues.

Edward Morales, Ph.D., has served as Division 44's liaison to Division 45 and is pleased to announce that 45 has set up a Task Force on Lesbian and Gay Issues to examine the ways in which lesbian and gay issues can be addressed by ethnic minority psychologists. Dr. Morales reports that the leadership of Division 45 is very supportive and is looking for members of 44 and 45 to serve on the task force.

The committee recommends that Division 44 establish an award to honor psychologists for outstanding achievements which help to further the understanding of ethnic minority lesbians and gays. Drs. Amy Reynolds and Connie Chan will develop criteria for this award and a procedure which would be compatible with SPSLGI's current awards process.

Long Range Planning

(Armand Cerbone, Ph.D., Chair)

In August the Long Range Planning Committee (LRPC) agreed to develop a telephone tree of Division 44 members. This telephone tree would provide the division with a fast and effective means of mobilizing its membership to respond to issues of national import and relevance.

The first procedure in establishing such a telephone tree will be the compiling of a mailing list synthesized from the membership rosters of Division 44 and ALGP. After establishing a common mailing list and organizing it into regions, members would be polled by mail for interest and consent. Each person would be responsible for contacting between three to five other members.

COUNCIL OF REPRESENTATIVES REPORT

The following article was prepared from materials submitted to Division 44's Executive Midwinter meeting, March 3-4 by Oliva Espin, Ph.D., SPSLGI's Representative to APA's Council of Representatives.

The Council of Representatives meeting in February, 1990 was rather peaceful. Most of the items brought to Council that are relevant for Division 44 were informational. My report is dividied into three parts: state of APA, informational items relevant to Division 44, and new Council decisions.

The state of APA. The financial situation of APA has stabilized. The 1989 budget carried the greatest surplus in APA's history. Membership in APA has not declined in this first year of APS's existence; in fact, there has been a 144% increase of interest in joining APA's divisions. APA's new home is under construction, details of its contract were discussed. The organization's directorates are working hard. A new Education Directorate has been established. I am a liaison to this directorate and have submitted comments regarding ethnic and gay and lesbian minority issues in the process of accreditation and in the establishment of the directorate.

Informational items relevant to Division 44. Bryant Welch, Executive Director for Professional Practice, presented a statement on January 28 at a press conference held during the Traditional Values Coalition Symposium. The statement pointed out that homosexuality is neither a mental illness nor moral depravity and that study after study [has documented] the mental health of gay men and lesbians, suggesting that efforts to repair*homosexuals are nothing more than social prejudice garbed in psychological accountements.

In November, Jacquelyn H. Gentry, Director of the Office of Social and Ethnical Responsibility, testified before the Congressional subcommittee on Civil and Constitutional Rights on the issue of granting, denying, and revoking security clearances. She testified that homosexuality as a disqualifying criterion or a reason to extend an investigaton has not been validated and reflects beliefs about homosexuality--that it is sick, that homosexuals

are ashamed and easilty blackmailed, that gay men and lesbians are prone to illegal acts and lying--for which there is no supporting evidence and substantial contradictory evidence.

APA has won Congressional approval as a Medicare provider. In general, it is important for APA-approved training programs to incorporate knowledge and intervention techniques with the elderly in their curricula. Specifically, issues of gay and lesbian eldery should be incorporated in these training programs.

A motion proposed by Steve Morin concerning HIV positive clients and the duty to warn third parties did not pass the Council. The proposal held that there was no explicit duty to warn, however psychologists have an ethical responsibility to examine individual cases to determine risk of HIV infection to third parties.

New Council decisions. The Council created the Board of Applied Psychology in the Public Interest (BAPPI). This board will be concerned with the use of psychology for the benefit of individuals who are discriminated against due to class, gender, sexual preference, disability, and other demographic factors. A conflict of interest/self-awareness qustionnaire was approved on a trial basis. Approval to develop new regulations about guidelines promulgated by APA divisions was given. Finally, APA's membership will be asked to vote on a by-laws change allowing a non-psychologist to become APA's Chief Executive Officer in the event that the organization's CEO is unable to serve.

AIDS

The AIDS Resource Network. The APA Office on AIDS developed the AIDS Resource Nework to serve as an information and resource guide for health professionals. The network's computer file now holds information on approximately 240 psycho-

logists who currently are working on AIDS research, service delivery, prevention, or policy issues. President-Elect

Connie Chan, Ph.D.

Division 44 represents something unique and very wonderful within APA. As a member and later Chair of APA's Committee on Lesbian and Gay Concerns (CLGC), I learned much about the workings of APA. I also learned that Division 44 was in the forefront in creating a supportive place for lesbian and gay psychologists. and I have been proud to be part of the leadership of 44. My background experience in Division 44 includes serving as a Member-at-Large of the Executive Committee for three years, serving on the Program Committee, and currently chairing the Committee on Ethnic/Racial Minority Concerns. She is currently a member of the faculty of the counseling psychology program at the University of Miami. Her main goals in serving as President-Elect would be to increase outreach to and participation by ethnic and racial minority psychologists in the Division.

Member-at-Large

Armand Cerbone, Ph.D.

I am asking for your support of my candidacy for Executive Committee Member. Since 1985, the year in which Divison 44 was established. I have been active in Division affairs. I organized the Division's first regional caucus in the Midwest, and have served as co-chair of the Committee on Future Directions. Since 1987 I have been on the Steering Committee of the Association for Lesbian and Gay Psychologists, serving as its most recent chair. During my tenure as Chair of ALGP, we replenished its depleted treasury, refocused the organization's mission to be at once distinct from and yet complementary to the work of Division 44. and stimulated new membership and volunteerism. As a member of the Executive Committee, I would continue mobilizing the Division's membership into regional caucuses. Local groups provide more meaningful support to individuals and give them a more effective voice within the Division. They create structures through which the division can respond more swiftly and sensitively to issues of homophobia whenever and wherever they arise. Some Division members have suggested we hold a mid-winter divisional conference in a city where APA does not typically meet. I support such a suggestion and would work to realize it as an Executive Committee member. Such meetings keep alive the spirit and professional exchanges that the conventions in August generate. They offer to members not able or not inclined to attend the large convention opportunities to participate in the larger

life and mission of the Division.

If elected, I believe I would bring to the Executive Committee proven organizational skills and a record of effective leadershlip at both local and national levels.

Royce Scrivner, Ph.D.

I have extensive experience as a psychologist and an activist for gay and lesbian issues. I have served as the director of an APA-approved internship program in psychology, was treasurer of the Texas Psychological Association (TPA) Division of Applied Psychology, established the TPA Lesbian and Gav Research Fund, and was director of the TPA Division of Applied Psychology, in which capacity I published the division's first newsletter and appointed ten new committees including a Committee on AIDS with sub-committees on Black and Hispanic Issues. In 1987 I was named the Dallas Psychological Association's "Psychologists of the Year", and in 1989 received the TPA Division of Applied Psychology award for "contributions to the professional practice of psychology." I am curently

on the Board of Directors of the TPA Political Action Committee, and am TPA Liaison Officer for Organization Affairs.

I was a consultant to the Dallas Gayline from 1976-86, and coordinated the first APA Convention CE work on "Family Therapy: Lesbian and Gay Issues", as well as conducting similar workshops for TPA. I have presented on issues of lesbians and gays, ethnic minorities, and family therapy ethics for both Division 43 and 44 programs. I served as the Liaison from TPA to the APA Committee on Lesbian and Gay Concerns in 1984, the time at which I came out openly gay in the profession.

I decided to begin addressing lesbian and gay issues at the state level. In Texas I successfully used a grassroots approach in addressing lesbian and gay, and other professional issues. For two years I have attended meetings of the Council of Executives of State Psychological Associations and networked with people in other states. Now, I would like to serve as a Division 44 Member-at-Large and in that role enhance how that issue is addressed in psychology in other states.

SPSLGI PUBLISHES ANNUAL

The Society for the Psychological Study of Gay and Lesbian Issues of the American Psychological Association announces a call for papers for its new annual publication: Contemporary Perspectives on Lesbian and Gay Psychology: Theory, Research and Clinical Applications, Vol. 1.

The scope of this volume encompasses the broad areas of theoretical analysis or development, literature reviews, public policy implications, training and education of mental health practitioners on lesbian and gay psychology, clinical applications, reserach, standards of practice and ethics in this area. Contributions from all branches of mental health, human services, and behavioral sciences are welcome. Papers reflecting the diversity of the lesbian and gay community are encouraged.

Intructions to contributors: Style as detailed in the APA Publication Manual, 3d. Edition should be used. Division 44 Editorial Policy and APA Standards for the use of nonsexist language should also be followed. Authors of research articles will be required to submit a statement demonstrating that APA ethical standards were uphled in the conduct of the research. Human subject samples must be representative of the populations to which results are to be generalized. When samples are not representative, limitations on the generalizability of results must be noted explicitly in the body of the paper and the abstract, and should be reflected in the title of the paper.

AMERICAN PSYCHOLOGICAL ASSOCIATION REPORT

The following article was prepared from materials presented to Division 44's Executive Committee at their Mid-Winter Meeting, March 3-4, by Clinton Anderson and William Bailey of APA's Public Interest Directorate.

Hate Crime Statistics Act. On February 8, 1990 the U.S. Senate adopted legislation which would require the Justice Department to collect statistics on crimes against persons motivated on the basis of race, religion, ethnicity, or sexual orientation. Despite a major battle on the floor of the Senate around the sexual orientation piece, the legislation, which was a major priority bill for the APA's Public Interest Directorate, appears to be headed for a presidental signature in the near future.

Since the original concept of including sexual orientation was identified by Greg Herek, former chair of APA's Committee on Lesbian and Gay Issues, in a meeting with staff from the National Gay and Lesbian Task force, and APA, psychology has played a major role in assuring favorable action on the bill. In the fall of 1986, hate crimes legislation introduced by Congresswoman Barbara Kennelly (D-CT) was stagnating in the House Judiciary Committee, Herek and others identified this measure as an ideal vehicle for advancing the issues around anti-gay violence. NGLTF and APA, which were able to fashion a rather findable coalition, interested Congressman John Conyers (D-MI) in reintroducing a new measure which included sexual orientation.

When the 101st Congress began, the hate Crimes Coalition was able to get the bill swiftly through the House. Similarly the Senate author of the measure, Paul Simon (D-IL) was able to move the bill from introduction through Senate Judiciary Committee Consideration rather expeditiously. Once the bill was in line for floor consideration, however, Jessie Helms (R-NC) signaled his intent to hold the bill hostage to his small-minded efforts to do damage to the gay community. Ultimately however, the Hate Crimes group was able to enlist the support of enough Senators to push the leadership to consider the bill. Notable in his advocacy both behind the scenes and on the floor was Utah Republican Orrin Hatch, the ranking minority member on the Senate's

Health Committee. During Helm's effort to damage the gay community, Hutch came forward, disputing Helm's claims about the bill's impact and intent.

The Hate Crimes coalition strategy offered a floor amendment giving Senators the "political cover" they needed to defeat a Helms. This "preemptive strike" language, offered by Senators Simon and Hutch, was consistent with the actual impact of the bill and indicated that the bill did nothing to promote or encourage homosexuality. The amendment was adopted with virtual unanimous support. When Helms stood up and offered his offensive provision which suggested that gays were a threat to the foundation of American society and the state sodomy laws should be enforced, he was defeated 77 to 14. This was a landmark, a defeat to Jessie Helms, the gay and lesbian community's foe in the Senate.

While APA and Division 44 can take great credit for this because of their efforts in support of this legislation success, the bill is not yet signed, sealed and delivered. Moreover, once enacted the gay community must continue its vigilence to ensure apporpriate administration of the statute. Homosexuality and Security Clearances. Jacquelyn Gentry, Director of APA's Office of Social and Ethical Responsibility, testified at a hearing on standards and due process for granting, denying, and revoking security clearances on November 2, 1989. APA's testimony recommended that homosexual behavior and a history of psychotherapy or counseling should not be criteria in security clearance decisions, that all psychological tests should be used in strict accord with professional standards, and that applicants' due process rights should be guaranteed.

Gay and Lesbian Military Freedom Project. The GLMFP coalition includes ACLU, NGLTF, NOW, HRCF, Lambda Legal Defense and Education Fund, National Lawyers Guild, and Citizen Soldier. APA's role will be to help develop research agendas for addressing the government's justifications and enforcement of statues and regulations that prohibit homosexual behavior and that restrict gays and lesbians from serving in the military. MMPI Use in Screening Out Gay Police

Applicants. APA has been contacted regarding a possible suit against the Los Angeles Police Department being brought by former officers who allege they were discriminated against because they are gay. One aspect of the case is the use of the MMPI M-F scale as a sceening device to eliminate gay applicants.
