### REFLECTIONS

SARI H. DWORKIN, DIVISION 44 PRESIDENT

It's hard for me to believe that it's time for the convention issue of the newsletter. I find the convention issue to be extremely useful. The convention program is so huge that I often am overwhelmed by it. Our convention newsletter helps me to pinpoint the sessions I want to attend.

This is actually my last column as president of the division. I can't believe how quickly time goes as we get older. Here I am on sabbatical, under less time pressure, and yet

finding each day filled with activity. I wonder how I usually do all of this work on top of a full time job. I've had the luxury of stopping work around 5 PM and enjoying my weekends free from work. What a culture shock the fall will be. There still is much for me to do as we prepare to go to Chicago. I don't even have my presidential address written yet (as of the deadline for newsletter submission; hopefully by the time you are reading this column it will be completed).

### FALL NEWSLETTER THEME: CHILD MOLESTATION AND HOMOSEXUALITY

In the wake of the many cases of priests and other religious professionals molesting children in their care, a number of people, some of them high-ranking religious professionals, have stated that they see the problem as stemming from the high number of gay priests. They seem to think (or choose to say they think) there is a connection between homosexuality and pedophilia or between child molestation and same-sex orientation. There has been talk on the Division 44 list serve suggesting that the APA or the Division should draft a response to such claims, however it was concluded that the process of drafting and approving such a statement is so complex and lengthy that by the time such a statement were approved, the time for it might have long since passed. There is a felt need among many to respond in a more specific way to these recent statements by church officials and others. Toward that end, Jim Fitzgerald (our division president-elect) has proposed a thematic issue of the fall 2002 newsletter. James Cantor has agreed to write the lead article on this topic, and others (this means you!) are invited to send in letters to the editor or short articles on this topic as well. The deadline for submissions for that newsletter is August 15. You are also welcome to contact me at [beckyliddle@mindspring.com](mailto:beckyliddle@mindspring.com) or Jim Fitzgerald at [Jfitz404@aol.com](mailto:Jfitz404@aol.com) with ideas or suggestions. In addition to letters or articles addressing the problem of claims that gay priests are a risk to children, we are interested in letters that comment on how the Division should handle the issue both within and outside of APA. Submissions and letters for the fall newsletter should be sent to me by August 15. Email/electronic submissions are preferred.

My practice includes adult psychotherapy and forensic psychology, including custody evaluations with LGBT parents -- Dr. Suzanne Johnson and I are offering a day-long CE workshop in Chicago on this topic. I'm also running a national survey on confidentiality in psychotherapy and would love to hear from Div. 44 members about this subject.

**Dawn Szymanski** accepted a tenure track, assistant professor position for the Division of Counseling and Family Therapy at the University of Missouri, St. Louis. She will begin Fall 2002.

**Henry L. Minton** announces his new book, "Departing from Deviance: A History of Homosexual Rights and Emancipatory Science in America" (Chicago: University of Chicago Press, 2002). This book looks back at the struggle of the American gay and lesbian activists who chose scientific research as a path for advancing homosexual rights. The history of gay and lesbian emancipatory research is traced from its early beginnings in the late nineteenth century to its role in challenging the illness model of the 1970s.

## Adults & Children Together (ACT) Against Violence National Training Program - Fall Workshop

The APA Public Interest Initiatives Office is inviting qualified psychologists to submit an application for the second workshop of the ACT National Training Program. The ACT – Adults and Children Together – Against Violence project addresses violence prevention in the critical years of early childhood, ages 0 to 8, by focusing on the most influential adults in children’s lives – parents, teachers, and caregivers. Participants are trained to create or help create initiatives to disseminate the ACT program message and materials to adults in their communities. They are expected to take an active role in conducting workshops and implementing training programs, and/or making presentations to professionals, parents or other family members in their communities.

The tentative date for the 2 ½ day workshop is September 26, 27, 28. The workshop and materials – ACT Training Manual, ACT Implementation Handbook, ACT Resource Materials Booklet – are free and travel expenses are covered by a grant from the MetLife Foundation. The ACT Training Program is approved for continuing education units.

The ACT National Training program trains professionals to create community initiatives and implement the program through local organizations and communities. The National Training Program consists of a 2 ½ day workshop which provides instruction on how to implement and evaluate the ACT training program, how to work with diverse groups of adults, how to disseminate information on child development, how to select intervention programs, and how to design an action plan. Additionally, it offers workshop modules addressing core violence prevention skills – problem solving, anger management, discipline, and media literacy. Aside from their responsibility to implement the ACT Training Program, participants are expected to train professionals to further disseminate the ACT project.

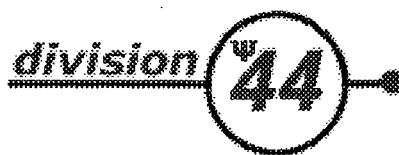

## SELECTED MISSION STATEMENTS – APA BOARDS AND COMMITTEES

### **Council of Representatives**

There shall be a Council of Representatives which shall be the legislative body of the Association and shall have full power and authority over the affairs and funds of the Association within the limitations set by the Certificate of Incorporation and these Bylaws, including the power to review, upon its own initiative, the actions of any board, committee, Division of affiliated organization.

### **STANDING BOARDS (DEFINED IN BYLAWS)**

#### **Board of Directors**

The Board of Directors shall be the administrative agent of Council, shall supervise the work of the chief staff officer of the Association and shall exercise general supervision over the affairs of the Association. In the interval between Annual Meetings of Council, the Board of Directors shall have authority to take such actions as are necessary for the conduct of Council. If an emergency is declared by a majority of the Board of Directors, the Board shall have power to take actions as though such action were taken by Council. The Board of Directors shall make a report of such emergency actions not later than the next meeting of the Council. It shall furnish a report of all such transactions at each business meeting of Council held in conjunction with the Annual Convention.

#### **Board for the Advancement of Psychology in the Public Interest**

The mission of the Board for the Advancement of Psychology in the Public Interest shall be to encourage the generation and application of psychological knowledge on issues important to human well being. It shall have general concern for those aspects of Psychology that involve solutions to the fundamental problems of human justice and that promote equitable and just treatment of all segments of society. BAPPI shall encourage the utilization and dissemination of psychological knowledge to advance equal opportunity and to foster empowerment of those who do not share equitably in society's resources. The Board shall be concerned with increasing scientific understanding and training in regard to those aspects that pertain to, but are not limited to, culture, class, race/ethnicity, gender, sexual orientation, age, and disability. The Board shall support improving educational and training opportunities for all persons in psychology and continue the promotion of culturally sensitive models for the delivery of psychological services. The Board shall be sensitive to the entire range of APA activities as they pertain to the mission of this Board and make recommendations regarding ethically and socially responsible actions by APA when appropriate.

#### **Board of Convention Affairs**

The Board of Convention Affairs shall consist of not fewer than six Members of the Association, three to be elected every other year for a term of not less than four years. The President may each year appoint to this Board one or more Members of the Association for terms of one to four years at his/her discretion. It shall be the responsibility of this Board to recommend policies and procedures to be followed in planning the Annual Convention, to coordinate the programs of Divisions and other organized groups within the Association, and to arrange for programs of general interest at the time of the Annual Convention.

#### **Board of Educational Affairs**

The Board of Educational Affairs shall consist of not fewer than twelve members of the Association, who shall serve for terms of not less than three years each. It shall have general concern for educational and training affairs which transcend more than one Division or group of psychologists. Members of the Board of Educational Affairs shall be selected to represent the range of interests characteristic of psychology in all its aspects.

#### **Board of Professional Affairs**

The Board of Professional Affairs shall be responsible for developing recommendations for and monitoring the implementation of APA policy, standards and guidelines for the profession of psychology, maintaining relationships with other professional organizations and groups appropriate to its mission, recognizing contributions to the profession of psychology through awards and honors, proposing to the Association ways to enhance the profession of psychology, and fostering the application of psychological knowledge in order to promote public welfare.
